- The school will provide to parents reports/report cards every nine weeks with information regarding their child's academic progress and upcoming classroom and school events. (Connie Howard—Every Nine Weeks)

- The meetings will be held at various times during the day or evening to better accommodate parents. (Georgia Chastain, Mike Nash, Meredith Jones—Quarterly)
- Teachers will hold conferences individually with parents of children in their classrooms. Parents will be given a summary of the student's test scores and an explanation of the interventions teachers are using to assist the child in reaching achievement goals. Parents will be asked to engage in discussion of how they can support these efforts. Parents will also be given suggestions for coordinating school-parent efforts and explanations of homework and grading procedures. (All Teachers and Principals—October and March)
