- The school principal will distribute a monthly newsletter (Smores) to parents that is developed with participation of the PTO, staff, and parent volunteers. It includes school news and a calendar of school activities. (Weekly, Casey Hanna)
- Parents can access their child's grades using a PIN number they received at the beginning of the school year. Parents may use e-mail to communicate with members of the school staff. (August, Brandy Koski)
- Each teacher will send home a folder containing student papers and work samples each week. Parents will be asked to sign the folder and send it back to school. (Weekly, Casey Hanna)
- Teachers will routinely contact parents on an individual basis to communicate about their child's progress. (Weekly, Casey Hanna)
- The school will provide to parents reports/report cards every nine weeks with information regarding their child's academic progress and upcoming classroom and school events. (Quarterly, Casey Hanna)
- The school will send parents their child's test results and standardized test scores before their first nine weeks report card. (September, Casey Hanna)
- Teachers will send weekly newsletters home containing skills to be taught and upcoming class events. (Weekly, Casey Hanna)
- The Parent Center will be available Monday through Friday from 7:30 am to 4:00 pm for parents to check out materials and manipulatives to enhance their child's education and support their classroom instruction. (Daily, Andrea Neville)

Southside Elementary Parent Night: October 6th, 2015

- Parent Night includes a movie with a preview each grade level designs with a Sneak Peak that is designed to showcase the grade level to the parents. The video will also include ideas on how parents can help their children at home with skills. (October 6, 2015: Casey Hanna, Andrea Neville, Grade Level Teachers)
- Parent Teacher Conferences Fall Dates: October 19th, 20th, and 22nd 3:00 to 6:00 pm and Spring Dates March 14th, 15th, and 17th from 3:00 to 6:00 pm. (Casey Hanna, Lori Bridges, Grade Level Teachers)

- These meetings will include parent training sessions to help parents understand how to enhance their child's education. (Twice a year: Casey Hanna, Grade Level Teachers)
- The meetings will be held at various times during the day or evening to better accommodate parents. (Twice a year: Casey Hanna)
- Teachers will hold conferences individually with parents of children in their classrooms. Parents will be given a summary of the student's test scores and an explanation of the interventions teachers are using to assist the child in reaching achievement goals. Parents will be asked to engage in discussion of how they can support these efforts. Parents will also be given suggestions for coordinating school-parent efforts and explanations of homework and grading procedures.(Twice a year: Casey Hanna)
- The school will offer parents a Parent Night each year (this year was September 30th) to provide and explanation of the statewide assessment system, standards, and other accountability measures. (October 6th: Casey Hanna)
