Pre-K Enrollment FAQ's

Bring the following to your registration appointment:

- 1. Copy of Birth Certificate
- 2. Copy of Social Security Card
- 3. Proof of income for **ALL adults** in the home equal to 1month worth of pay. *the most current 30 days

 Or a No Income Statement for anyone not working. (weekly 4 checks, bi-weekly 2 checks, monthly 1 check)
- 4. Current utility bill for proof of residency
- 5. A current shot record- the final series of shots cannot be given until after your child's 4th birthday
- 6. Physical (may be either the 3 or 4-year-old well check)
- 7. Parent / Guardian ID or Guardianship paperwork
- 1. How many Pre-K students can enroll? We have positions for 340 four-year old's. What happens once all 340 slots are filled? Students are placed on a waiting list. You will be contacted as a slot becomes available.
- 2. **How is my child's Pre-K school chosen?** Pre-k programs are offered in six (6) of our schools: Central, Magness Creek, Mountain Springs, Northside, Ward Central and Westside. Students are placed according to their address. Parents will be notified regarding their child's placement.

- 3. **Do all Pre-K students attend free of charge?** No. A sliding scale is used to determine a child's placement based on family income and number in the household. Tuition students may also attend. Tuition amount is based on income using a sliding scale that may range from \$27-\$160 per week. Parents may be required to pay for breakfast / lunch if not enrolled in free/reduced meals. A USDA EZ MEAL APP as well as the CACFP Snack Enrollment form will be provided to all Pre-K families prior to school starting.
- 4. What are the hours of operation? Pre-K has the same hours as all schools. Students cannot be dropped off prior to 7:30 a.m. and must be picked up no later than 3:30 p.m.
- 5. **Does Cabot School District provide transportation?** Yes. Pre-k students are able to ride school buses. Pre-K students sit at the front of the bus nearest the driver and are signed on/off the bus by school personnel. An approved person (over 18 yrs) must be present at the bus stop each morning/afternoon to sign child off the bus. Riding the bus is a privilege afforded by the school district, but privileges may be revoked at any time children are not following the school bus riding rules. Students may also be a car or day care rider. Pre-k students may begin riding the bus after the first two weeks of school with approval from transportation. Parents must provide transportation until this time. **If you have a transportation question concerning a pre-k student please call the Pre-K Dept. at 501-843-3363 ext. 1014.**
- 6. Does Cabot School District provide afterschool care for Pre-K? No.
- 7. When will I know where my child will attend? Students will be placed in a school once the 2-step application process is verified. Those who have a met with their Family Liaison and returned a completed packet with all documents, completed online registration will be notified by the end of May.
- *It is vital to update your Family Liaison should any of your contact information change.
- 8. Why is it important to complete online registration and attend appointments? A student will not be registered until the appointment and online registration is complete.
- 9. How will I know who my child's teacher is? You will receive an acceptance letter in late May and a teacher placement letter the first week of August. May I request a teacher?
