

# Magness Creek Elementary Parental Involvement Plan

We welcome parents/guardians/caregivers to our campus and classrooms by providing a climate conducive to active parental involvement.

## **Goal 1: Magness Creek Elementary will use communication strategies to provide additional information to parents and to increase parental involvement in supporting classroom instruction.**

- The school will distribute a calendar of school activities that is developed with participation of the parent-school organization, principal, staff and parent volunteers. **Jacqueline Gaskins and PTO-August**
- The school will create a Web site where school information will be available. Also, parents can access their child's attendance using a PIN number they received at the beginning of the school year. - Each teacher will send home a folder containing student papers and work samples each week. Parents will be asked to sign the folder and send it back to school. **Teachers-ongoing**
- Teachers will contact parents on an individual basis as needed to communicate about their child's progress. **Teachers-ongoing**
- The school will provide to parents reports/report cards every nine weeks with information regarding their child's academic progress and upcoming classroom and school events. **Teachers-Quarterly**

- The school will send information home with students, post notices in school facilities and public buildings about parent meetings. **Magness Creek Staff-ongoing**
- The school will use the student handbook, school Web site, signage at the school entrance, and parent orientation meetings to provide information to parents. **Magness Creek Staff-ongoing**

## **Goal 2: Magness Creek will have parent meeting, conferences and activities regularly throughout this year and the dates providing flexible meeting times that you have planned to increase parental involvement and build staff and parent capacity to engage in these types of efforts.**

**Goal 3: Magness Creek will provide information to parents about volunteer opportunities.**

- The school will provide opportunities for parents and community members to support the instructional program through such programs as Reading Buddies, tutoring, and special friends. **Bankston-ongoing**
- The school will provide a list of volunteer opportunities and solicit ideas for other types of volunteer efforts during orientation of parents. Teachers will explain the requirements to parents and encourage them to become involved in the school. Brief training sessions will provide parents and community members with the information they need to participate as school volunteers in order to put them at ease and make the experience pleasant and successful. **PTO and Lindsay MacMillan, ongoing**
- Provide instruction to a parent on how to incorporate developmentally appropriate learning activities in the home environment, including without limitation: role play and demonstration by trained volunteer, the use of and access to the Department of Education website tools for parents, assistance with nutritional meal planning and preparation and other strategies or curricula developed or acquired by the school district for at-home parental instruction approved by the Department of Education. **Kristi Johnson, Monthly**
- (Staff Development) The State Board of Education's Standards for Accreditation of Arkansas Public Schools and School Districts shall require no fewer than two (2) hours of professional development for teachers designed to enhance the understanding of effective parental involvement strategies. No fewer than three (3) hours of professional development for administrators designed to enhance understanding of effective parent involvement strategies and the importance of administrative leadership in setting expectations and creating a climate conducive to parental participation. **Mrs. Bankston, August**

**Goal 4: Magness Creek will provide resources for parents.**

- The school will distribute informational packets each year that includes a copy of the school's parental involvement plan, survey for volunteer interests, recommended roles for parents/ teachers/students and school, suggestions of ways parents can become involved in their child's education, parental involvement activities planned for the current school year and information about the system that will be used to allow parents and teachers to communicate (notes, phone calls, e-mail...). **Jacqueline Gaskins and PTO-August**
- To promote and support responsible parenting, the school shall, as funds are available: Purchase parenting books, magazines, and other informative materials regarding responsible parenting through the school library, advertise the current selection, and give parents the opportunity to borrow the materials for review. **Mrs. Bankston and Lindsay MacMillan, as needed**
- Create a parent center. It is located in the front hallway next to the nurses office and is open during school hours and until 4:00 after school. **Lindsay MacMillan, ongoing**
- Include in the school's policy handbook the school's process for resolving parental concerns, including how to define a problem, whom to approach first, and how to develop solutions. **District, ongoing**

**Goal 5: Magness Creek will engage parents in the evaluation of your parental involvement efforts.**
