1: Jointly Developed

(Describe/List how parents will be involved in the development of the school parent and family engagement plan and how parents will be involved in the planning, review, and improvement of parent and family engagement programs.)

Parent input will be sought in the creation of the Family and Community Engagement Plan through electronic means, due to COVID-19 restrictions.

Ward Central will involve parents and community members to serve on the School Improvement Planning Committee each school year. This committee will meet in July before school starts to review and make revisions to the School Compact in order to prepare for the new school year. If unable to meet in person due to restrictions, technology such as e-mail and virtual platforms will be utilized to collaborate effectively.

All family and community members will be invited to join Ward Central's Parent Advisory Committee (PAC) for involvement opportunities and to assist in the evaluation and review of the Family and Community Engagement Plan annually. This invitation will be posted on Ward Central's Facebook page and advertised at Open House. A suggestion box and sign up sheet will be available at Open House for any family or community members who would like to be represented in a variety of roles throughout the school. Parents can also make requests about opportunities for regular meetings and family nights. These endeavors will allow ample opportunities to engage traditionally less engaged populations. Ward Central will also consider additional means of participation such as virtual platform meetings. (Emily Taylor-ongoing)

Ward Central will have the second annual September Parent Advisory Committee meeting in the fall of 2020. All decision making processes regarding the school's Title I, Part A program will be reviewed and discussed. If face-to-face meetings are not possible due to COVID-19 restrictions, technology such as e-mails, Google Forms, and virtual platform meetings will be utilized to ensure appropriate input opportunities are available.

Ward Central will administer the "High Reliability Schools Level 1 Survey" offered through DESE. Parents will be asked if they feel that Ward Central provides them opportunities for input regarding optimal functions of the school. For all core survey items last year, respondents were asked to rate their agreement on a five-point scale, from "strongly disagree to strongly agree." The mean response was a score of "4"

meaning that parents agreed that Ward Central provided them opportunities to review, update, and contribute. (Connie Reed-September 2020) Ward Central collected input through surveys from teachers in the spring of 2020, and will survey parents in the fall of 2020 to ensure a wide range of contributions into family and community engagement efforts. If face-to-face meetings are not possible due to COVID-19 restrictions, technology such as a virtual platform meeting or posting a recording to social media will be utilized in order to ensure parents have an opportunity to access the information. The plan will be posted on the district website by August 1. Parent signatures will be collected electronically with Registration Gageway during new student and back to school online registration. (Emily Taylor-August 1)

Ward Central Elementary will provide a Family and Community Engagement Packet that contains a description of the Family and Community Engagement Plan, recommended roles and ways for families to be involved, a survey of volunteer interests, a schedule of activities, and a system of regular two way communication. Family and community engagement does not stop at the school doors. Ward Central encourages parents to help at home (e.g., planned home reading time, informal learning activities, and/or homework contracts between parents and children). The school will provide a calendar and list of volunteer opportunities in the packet and solicit ideas for other types of volunteer efforts during Open House and through surveys. Ward Central will use school staff and parents to jointly develop a School-Parent-Student Compact. This committee will review the parent surveys and the faculty needs assessment to help with outlining this new compact. The committee will address how parents, school staff, and students share the responsibility for improving student academic achievement and the means by which the school and parents will build and develop a partnership to help children achieve the state's academic standards.

Ward Central is responsible for providing high quality curriculum and instruction in a supportive and effective learning environment. The school will hold Parent/Teacher Conferences twice a year, at minimum. (Connie Reed-October 13th and 15th, March 16th and 18th) Parents will also have access to staff through meetings, phone calls, or other technology. Teachers will frequently report progress and communicate with parents, along with facilitating opportunities for parents to be involved in the classroom.

Parents are responsible for maintaining meaningful two way communication by responding appropriately. Parents are also responsible for supporting the school and teachers in their efforts to provide the best education possible for each student. Ward Central wants parents and families to be involved in their child's education. Research shows when schools, families, and community groups work together to support learning, children tend to do better in school, attend school more regularly, stay in school longer, and enjoy school more. Students are responsible for being respectful, being obedient, listening, working hard, being prepared, showing self-control, and being responsible for their behavior.

Ward Central believes that meaningful two way communication is important including Parent/Teacher conferences, progress reports, reasonable access to staff, opportunities to volunteer, and observation of class activities. If a parent wishes to observe class activities, the process includes speaking with the teacher and setting the date and time with the administrators. Parental involvement does not stop at the school doors. Parents are encouraged to help at home (e.g., planned home reading time, informal learning activities, and/or homework contracts between parents and children). The school will provide a list of volunteer opportunities and solicit ideas for other types of volunteer efforts during Open House and through parent surveys. Information from the volunteer survey will be compiled into a volunteer resource book for staff. Some examples of volunteer opportunities include chaperoning field trips, mentoring, and assisting with the Ward Central Veterans Day Celebration. Training sessions will be provided for parents and community members with the information they need to participate as school volunteers in order to put them at ease and make the experience successful. Ward Central will engage parents in decisions about the allocation of its Title I, Part A funds for parental involvement and decisions made to create the school improvement plan. This will be assessed in the Parent Needs Assessment distributed in the fall of 2020. Ward Central will invite two community members to serve on the Parent Advisory Committee. Ward Central has a very active Parent/Teacher Organization that fosters parental and community involvement within the school. The Title I budget will be allocated from the input from these committees. The budget will also be reviewed at the Annual Title I meeting in September with an opportunity for parents to give input and ask questions.

During the 2019-2020 school year, funds were used at a "Desserts and Discussion Night" where teachers partnered with parents to work on academics and build relationships. This event had an impact on families, but the numbers were not as strong as they could be. Funds were also used for a STEM Parent Night that was unable to occur due to the COVID-19 Pandemic.

If face-to-face meetings are not possible due to COVID-19 restrictions, technology such as e-mails, Google Forms, and virtual platform meetings will be utilized to ensure appropriate input opportunities are available. During the September Parent Advisory Committee Meeting, the following topics will be addressed: a description and explanation of the curriculum Cabot Public Schools uses, Arkansas Academic Standards, results of ACT and MAP testing and how to interpret these results, Title I, Part A requirements, and how to use the DESE website and toolkit for parents http://dese.ade.arkansas.gov/. (Connie Reed, Emily Taylor-ongoing)

To promote and support responsible parenting, the school shall, as funds are available: purchase parenting books, magazines, and other informative materials regarding

responsible parenting through the school library, advertise the current selection, and give parents the opportunity to borrow the materials for review. Ward Central has a Parent Resource Center that is always available for parents. (7:15 a.m.— 3:40 p.m. Monday-Friday) This resource center has books and backpacks that can be checked out by parents to take home to use with their children. There are also resource materials available for parents to check out that can support social, emotional, academic topics, and assist with nutritional meal planning and preparation information. If COVID-19 restrictions persist, these resources will still be available for use. Ward Central will push out information regarding what resources are available and find ways to connect the resources to a parent who shows interest. (Emily Taylor-ongoing)

- Ward Central will provide instruction to parents on how to incorporate
 developmentally appropriate learning activities in the home environment,
 including without limitation: role play and demonstration by trained volunteer,
 the use of and access to the Department of Education website tools for parents,
 assistance with nutritional meal planning and preparation as part of the Health
 and Wellness plan and other strategies or curricula developed or acquired by the
 school district for at home parental instruction approved by the Department of

- Ward Central will conduct a Literacy Family Night and Science/Technology
 Family Night. Teachers will share strategies with parents to support their child's
 academic progress. Teachers will also share with parents how to incorporate
 developmentally appropriate learning activities at home. If social distancing
 guidelines restrict such activities, Ward Central will be innovative in finding
 ways to share strategies using technology such as e-mails, Google Classroom,
 videos, and virtual platform meetings. (Connie Reed, Emily Taylor-ongoing)
- Hallway Heroes training is offered and advertised at Open House to encourage
 volunteer participation. Possible activities for Hallway Heroes are greeting
 students as they arrive, assisting with lunch and/or recess duty, monitoring
 hallways, entrances, parking lots, playgrounds, assisting office personnel and
 teachers with daily support tasks, eating lunch or playing on the playground with
 students, etc. (Michael Byrd-ongoing)
- The school will distribute informational packets each year that includes a description of the school's Family and Community Engagement Plan and how to access it, a survey for volunteer interests, recommended roles for and ways for parents to be involved, family and community engagement activities planned for the current school year, and information about the system that will be used to allow parents and teachers to communicate such as Remind and Dojo. - Parent/Teacher Conferences are held a minimum of twice a year. These
 conferences are scheduled to develop a partnership with teachers and parents to
 support student's academic achievements. Teachers will discuss individual
 student assessment results. If face-to-face meetings are not possible due to
 COVID-19 restrictions, technology such as virtual platform meetings, e-mails, or
 phone calls will be utilized. (Connie Reed-October 2020, March 2021)
- Teacher's planning periods are used to conference with parents, as needed. If face-to-face meetings are not possible due to COVID-19 restrictions, technology such as virtual platform meetings, e-mails, or phone calls will be utilized. (Connie Reed-ongoing)
- Grade-levels will schedule an activity this school year with their parents to discuss how the parents can help their children at home. If social distancing guidelines restrict such activities, Ward Central will be innovative in finding ways to share strategies using technology such as e-mails, Google Classroom, videos, and virtual platform meetings. (Connie Reed, classroom teachers-ongoing)
- Events such as Cookies with Santa and Family Track Night are scheduled to provide parents with ideas to help their students academically as well as further develop school-family partnership. If social distancing guidelines restrict such activities, Ward Central will be innovative in finding ways to share strategies using technology such as e-mails, Google Classroom, videos, and virtual platform meetings. Ward Central's teachers received two hours of professional development to enhance their understanding of effective parental involvement strategies during the 2018-2019 school year. In the district's policy handbook, the school's process for resolving parental concerns, including how to define a problem, whom to approach first, and how to develop solutions can be found. Ward Central will continue to follow state guidelines for family and community engagement professional development requirements. Training will include recognizing the integral role of parents in student learning, how to communicate with parents to support student learning as equal partners, coordinating parent programs to strengthen ties between home and school, and welcoming parents to the school community. Staff will be trained to provide information in ways that parents will readily understand and to value the contributions of parents.
