Motion by Donna Nash, second by Brian Evans; passed 7-0.


The board voted to approve the 2019-2020 school year budget as presented, including all State Categorical and Federal budgets.

Motion by Donna Nash, second by Pam Clem; passed 7-0.


The board voted to approve personnel as presented.
