- Mystery readers, representing diverse backgrounds such as veterans, parents, and professionals aligned with classroom topics, read aloud to students
- Speech, Occupations, and physical therapists from local schools and clinics educate students on Diverse Abilities Day
- Modern Woodmen of America donates instructional materials including books
- Magness Creek Elementary will coordinate and integrate family and community engagement activities to include early childhood programs and/or college & career readiness resources as appropriate. (Amanda Davis, classroom teachers, ongoing)
  - My Future Story counseling lessons that focus on college and career readiness during the month of May

  - The PreK family coordinators at each elementary school, including at Magness Creek Elementary, host 3 sports family nights a year for Pre-K students and their families. Families are invited to games at Cabot High School. Admission is free for students and one parent.
  - The PreK family coordinator creates book bags as resources to be sent home with every student. The bags include: picture book, fine motor skills practice, gross motor skills practice, and activities to do as a family.
  - The PreK family coordinator hosts a Parent Cafe night that includes a guest speaker that provides a presentation on various parenting skills.
