Parents will be provided with an electronic link to a survey allowing them to request assistance in helping their student be successful. Parents can also communicate with teachers through apps like Remind, Classroom DOJO, and HAC (Home Access Center) for updates on their child's progress and information about class activities. These applications also give teachers access to inform parents of volunteer opportunities and other needed parent roles as well. Cabot Middle School South also has a Parent Resource Center that parents can use to learn about these roles and opportunities. Progress reports are sent home at the midway point of each nine week period. (Mandy Green, ongoing)
