CURRICULUM REPORT

ELL Program – Dr. Melanie Duerkop introduced the English Language Learners (ELL) staff in attendance. Julia Shoemaker presented information on the ELL, also known as English to Speakers of Other Languages (ESOL), program. Over the last 10 years, the number of ELL students has grown from 100 to 400. There are currently 22 languages spoken within our district. The Seal of Bi-literacy program was started at the high school, and we had five recipients in the fall and 21 in the spring.

Summer Professional Development Opportunities – Sherri Jennings provided an overview of summer professional development opportunities for staff members this summer. Teachers will obtain 18 hours of professional development on their own, and an additional 18 hours will be provided during the back to school days.

Technology Report – Andy Martin shared the summer plans for the technology department. They will be working on device rollovers for students and staff. First, fifth, and

Technology is continuing to look into options to be able to provide internet service to students and staff who do not have internet at home once the state-provided hotspots that were provided due to COVID expire.
