Purple Star School Citation – Aaron Randolph shared the process of becoming a Purple Star School, showing the district's commitment to supporting military families. Representative Brian Evans presented a state citation recognizing the Cabot School District as the only district in Arkansas to have all schools achieve Purple Star School status. He also read a letter from Governor Hutchinson congratulating the district on being recognized as Arkansas's first Purple Star School District.

CURRICULUM REPORT

National CTE Month – Nicole Gatewood provided an overview of the Career and Technical Education opportunities the Cabot School District offers. We have twenty-three career programs, and students leave with certification in several of them. Some of these programs, such as automotive, construction, and CNA, prepare students to go to work immediately upon graduation. The many class offerings provide students with the opportunity to explore specific career paths.

Jr. ROTC Programming – Major Gibson, Cabot Jr. ROTC instructor, proposed additional classes to be offered in the Jr. ROTC program. These classes would consist of Leadership Development, Drill and Ceremonies, and Ground School.

ACE Conversion Charter School Amendments – Aaron Randolph reviewed amendments that will be submitted to DESE for our ACE Conversion Charter School. These amendments would allow digital learning at ACE and would adjust enrollment and class size numbers.

Building and Grounds – Michael Byrd reported that the final walk through and punch list should be received this week for Northside Elementary. Bids will be opened for the health services and museum building on Thursday.
