CURRICULUM REPORT

PLC Update – Aaron Randolph reported that the PLC groups have been working with colleagues around the state on the PLC process. The next meeting is June 15 and the Cabot School District will be presenting at the meeting. Stacy Allen shared that six schools applied to be in the PLC cohort and all six were accepted.

SUPERINTENDENT'S REPORT

Year-End Activities Report – Athletic Director Scott Reed reported that there were 1657 athletic participants in junior and high school this year. The high school competed in 24 sports. Three college signing days were hosted and 30 students signed with scholarships to play in college. Free sports physicals were provided to students in 8th through 12th grade. The Cabot School District coordinated several major athletic events: state tennis at Rebsamen, regional wrestling at Panther Arena, junior high conference track at Panther Stadium, state baseball at Cabot Baseball and Softball, and 4A state

softball at Cabot Baseball and Softball. Forty-four of 47 sports team held an average GPA of 3.0 or higher, with 26 of those teams holding a 3.5 or higher. Girls tennis held an average GPA of 3.97.

Buildings and Grounds – Michael Byrd reported the high school roof insurance claim is complete. A new roof was started today on the technology building. The slab has been poured for the CLA building and floor polishing will begin. There will be a 5:15 p.m. buildings and grounds work session at the June school board meeting.
