### CURRIGHE PARTERIES

**Wit and Wisdom Report** – Stacy Allen and Jenny Blackwell provided an overview of the Wit and Wisdom program the district currently uses in grades k-6<sup>th</sup>. This program focuses on rigor, relevance, and relationship in terms of reading. The district also purchased the inSync platform, which provides digital curriculum Wit and Wisdom for all students.

CPDA Update — Aaron Randolph reported that we currently have 1145 students enrolled in CPDA. Enrollment in CPDA is currently on hold for this semester unless a student has a medical reason to move to digital. CPDA enrollment for second semester will be open from January 11 through January 29, 2021. Focus groups were held to get feedback from students, parents, and staff regarding the digital academy. New courses will be added to the spring schedule for CPDA to allow for additional opportunities for students who prefer or need the digital platform.

  - K-12 non-classroom teachers (therapists, EL, G/T, etc.) that have both digitaland face to face students
    - \$300/semester
- Tier 2: Virtual teachers who are teaching over state mandated capacity.
  - o K-4 \$100 increment per semester exceeding max student threshold (1-5)
  - o 5-12 \$100 increment per semester exceeding max student threshold (1-10)
