MINUTES OF THE JULY 28, 2022 BOARD OF EDUCATION CABOT SCHOOL DISTRICT

Board President Joe Trusty called the meeting to order at 5:16 p.m. Those in attendance were school board members Pam Clem, Dr. James Hertzog, Kevin Tipton, and Marvin Jones. Also in attendance were Dr. Tony Thurman, Michael Byrd, directors, and community members. Board member Corey Williams arrived at 5:50 p.m., prior to any action items. Board member Sarah Owen was absent.

The Pledge of Allegiance and moment of silence were led by Board President Joe Trusty.

CONSENT AGENDA

Minutes from the regular June meeting were approved as presented.

June financials were approved as presented.

RECOGNITION

AAPT School Bus Safety Award – Morris Rothfeldt announced that the Cabot Transportation Department recently received the AAPT School Bus Safety Award and introduced the new Director of Transportation, Bob Doty. Both said that the award was achieved due to the outstanding work of the shop employees and bus drivers and their care in maintaining the safety of our fleet for our students.

CURRICULUM REPORT

School of Innovation — Cabot High School received the official designation as a School of Innovation, and Nicole Gatewood and Henry Hawkins shared information on the work behind the designation. The process began two and a half years ago in the fall of 2019 and involved a committee of various stakeholders. The following three goals were developed:

- 1) Social and Emotional Needs: Ensure students will develop the skills to effectively communicate/navigate life's challenges
- 2) Career Readiness: Ensure students develop a realistic plan and the skills necessary for their NEXT STEPS beyond high school
- 3) Make Curriculum Relevant: Students will have the opportunity to experience interdisciplinary curriculum that aligns with career readiness

Programs and ideas were generated to support and meet the needs for each of these goals.

SUPERINTENDENT'S REPORT

Security Update – Morris Rothfeldt provided an overview of process in looking at security upgrades for the district by defining risk and identifying how to manage and reduce it. Andy Martin, Aaron Randolph, and Lt. Roper shared pieces of the security plan, including updated access controls, RTI and behavior components with students, CRASE training for staff, CPR training, and increased SRO presence in buildings.

Buildings and Grounds Report - Michael Byrd reported that band practice area at the high school is now asphalted, and the MSS playground addition is complete. The five repair projects (HS, WC, WS, MSS, and ES) from the hail storm will begin soon. The CBI restroom projects at MSS and MSN are nearing completion. The work at the JHN field for the bleachers and walkways are complete. Dirt work continues for the new Junior High North driveway, and they hope to pour curbs in the next week or two.

Act 1029 Report – Michael Byrd presented the annual student discipline report as required by Act 1029. There were a total of 57 bullying reports submitted for the 2021-2022 school year, of which 24 were found to be credible reports.
