PARKING APPLICATION

As the parent/legal guardian of a student at Panther Academy, I hereby grant permission for my child to provide his/her own transportation to school and from school.

I understand that the Cabot School District is not liable for any damage done to the vehicle driven by my child while on any parking lot used by the Cabot Public School District. I also understand that all Cabot School District policies and Arkansas laws will be enforced on any parking area use.

We also agree to the following conditions:

- Arrive at school on time
- Once parked, students may not leave until their dismissal time unless approved by the principal
- Students must have a valid Arkansas driver's license
- Students must park in the assigned student parking area at all times
- Vehicle must have current insurance and registration at all times
- Trash should not be thrown from the vehicle.
- Students should never park in areas marked for individuals with disabilities. The Cabot Police Department will issue tickets for vehicles illegally parked.
- Students should not park in spaces marked for staff members.
- Students must exit the vehicle immediately upon arrival at school - no loitering.
- Students should not get into other student's vehicles in the parking lot.
- Excessive speed and/or careless driving will not be tolerated.

Truancy from school will also not be tolerated. Students that are found to be truant or leave campus without permission may lose parking/driving privileges.

Panther Academy is NOT responsible for any vehicle towed from parking areas used by students. All fines and penalties will be the responsibility of the vehicle owner.

Students will not be reimbursed for parking fees if parking privileges are revoked or denied due to failure to follow the above guidelines.

All personal property is subject to being searched by the Cabot School District. Please refer to the student handbook for guidelines on search and seizure.
