## Parking Regulations

As the parent/legal guardian of a student at Cabot High School, I hereby grant permission for my child to provide his/her own transportation to and from school. I understand the Cabot Public School District is NOT liable for any damage to the vehicle driven by my child while on any parking lot used by the Cabot School District. I also understand that all Cabot School District policies and Arkansas' laws will be enforced on any parking area used by Cabot High School.

Students may receive disciplinary action for parking illegally on the high school campus.

Repeated violations of the parking policy may result in the vehicle being towed and driving privileges being denied.

We also agree to the following conditions:

- Arrive at school on time
- Student must have a valid Arkansas Driver's License
- Park in assigned area at all times
- Register car and have a valid parking permit visible at all times
- Vehicle must have current insurance at all times
- Students who request driving/parking privileges will be entered into the random drug testing pool. Information on the Mandatory Drug Testing policy can be found at www.cabotschools.org
- Keep area clean around the vehicle. Trash should not be thrown from vehicles
- Students should never park in spaces marked for individuals with disabilities
- Students should never park in spaces marked for staff members
- Excessive speed and/or careless driving will not be tolerated

Cabot High School is NOT responsible for any vehicle towed from parking areas used by students. All fines and penalties are the responsibility of the vehicle owner

Students should arrive at designated parking locations with the consideration that it may take time to walk to the high school campus. Parking distance, weather and traffic congestion (trains) will NOT be considered acceptable reasons for being tardy or absent.

Students will not be reimbursed parking fee if driving privilege is denied for any of the above listed reasons.

If you lose your parking pass for any reason, you must purchase another pass for \$5.00.

All personal property is subject to being searched by the Cabot School District. Please refer to the student handbook for guidelines on search and seizure.

Wearing a seatbelt is mandatory.

## Students should exit vehicles IMMEDIATELY upon arrival at school

Truancy from school will not be tolerated! Students that are found to be truant, leave campus without permission, or have repeated tardiness may lose all parking/driving privileges on campus.
