PURPOSE

The Cabot Panther Hall of Fame was created in 2008 to celebrate the successes of public education by honoring talented graduates of Cabot Public Schools, as well as local leaders who have provided distinguished service to influence public school excellence.

GOALS AND OBJECTIVES

- To improve the overall academic performance and citizenship by stimulating intrinsic motivation and an appreciation for lifelong learning
- To foster pride in academic, athletic and performing arts by recognizing those who have been successful
- To increase parent and community awareness, support and involvement
- To acknowledge the accomplishments of alumni, faculty, staff and patrons
- To engage in fundraising activities in order to provide scholarships, grant funds and other opportunities beyond what can be accomplished through tax funds

NOMINATION CRITERIA

1. The nominee must fall into one of these three categories to be considered for the Panther Hall of Fame:
 - a. An alumni of the Cabot School District
 - b. A former faculty or staff member of the Cabot School District
 - c. A former or current community member of the Cabot School District (Austin/Cabot/Ward)
2. The nominee must have contributed in a significant way to the positive reputation of Cabot School District through their successes in the classroom, successes in competition or performance, successes in the community, or successes in life outside the community.
3. Alumni are eligible for nomination ten years after graduation from Cabot High School.
4. Faculty/staff are eligible for nomination five years after separation of employment with Cabot Public Schools.
