The JAG Board of Directors established the Kenneth M. Smith Scholarship Fund in honor of the extraordinary leadership and service of the first and only President and Chief Executive Officer of Jobs for America's Graduates, Inc., Kenneth M. Smith.

The Governance and Scholars Committees of the Kenneth M. Smith Scholarship Fund invested considerable time in reviewing the applications, transcripts, essays and support letters submitted by the 94 JAG applicants. You should be proud of your accomplishment since only sixteen (16) applicants will be recognized as a 2015 Smith Scholar.
